Sir/Madam,

This is with reference to your proposal submitted to the Council for establishment of a new Technical Institution under the name and style of **MAHAVIR INSTITUTE OF ENGG. & TECH. MAHAVIR NAGAR, GANGAPADA, BHUBANESWAR - 751 002.** for the academic year 2001-2002.

Your proposal, prima-facie, has been found to be acceptable based on the details furnished in your application form, the presentation in the Hearing Committee and the recommendations of the concerned agencies.

To facilitate further processing of the proposal you are now requested to furnish the following documents to the Eastern Regional office, AICTE, College of Leather Technology Campus, LB Block, Salt Lake City, Sector – III, Calcutta – 700 091 on or before March 20, 2001, the cut-off date fixed by the Council :

1. Registered sale deed "in original" showing absolute ownership and title of the proposed land and building in the name of the Trust/Society. It is the responsibility of the Trust/Society to ensure that the land and building is in the name of the Trust/Society and not in any individual's name.

In case it is planned to establish the proposed institution in the campus of an existing institution, the area as required for the proposed Institution (Annexure I) should be exclusively earmarked for the Institution. The area must be earmarked by an irrevocable resolution of the Trust/Society recorded on a non-judicial stamp paper duly notarised.

2. The land use certificate from the concerned Competent Authority;
 - (i) Municipal Corporation in the case of Metro-Cities, State capitals and District Headquarters
 - (ii) Panchayat or other Competent Authority in case of the areas are not covered in the Municipal Limits of Metro Cities, State Capitals and District Headquarters.
3. (a) A Cumulative Fixed Deposit only in a Nationalized Bank in the joint name of Trust/Society and the concerned Regional officer for a period of 10 years for the amount as applicable to the category of the institution indicated in the annexure to this letter(Annexure I). FDR should be created by duly obtaining the signature of the concerned Regional Officer on the FDR application form 'A'. (Please also refer the Procedure for creation of FDR at Annexure II). FDR should be cheked only in the Branch for which the signature of the concerned Regional Officer was obtained.

- (b) On redemption/maturity of the FDR, the applicant society may apply to the Council seeking permission to use the funds for development purpose of the institution.
- (c) The original FDR certificates shall be kept in safe custody of the concerned Regional Office.
4. A non-refundable inspection fee of Rs. 50,000/- (Rupees Fifty thousand only) in the form of a crossed (account payee) demand draft (Payable at the city where the Regional Office is situated) in favour of the Regional Officer, AICTE. Only after the receipt of the said fee, the Regional Office will consider further examination of the proposal for conducting inspection of your institution.
5. A registered undertaking on non-judicial stamp paper, stating that the institute shall abide by all the regulations, Norms, Guidelines and Standards of the Council, including that of constitution of the Governing body, (not applicable to Govt. and University Department), Staff Selection Committee and implementation of AICTE pay scales, alongwith Dearness Allowance and other benefits as applicable from time to time in the concerned state.
6. An affidavit on a non-judicial stamp paper confirming the compliance of all the conditions stated in Annexure III.

The Trust/Society is hereby informed that issuance of Letter of Viability by the Council does not automatically entitle it for grant of final approval.

You are to fulfill all the requirements indicated at 1,2,3, 4,5 and 6 at the earliest but not later than March 20, 2001, the cut-off date.


It shall be the responsibility of the Trust/Society to submit all documents strictly in accordance with the requirements of this Letter of Viability before the cut-off date. Failure to do so the application will stand rejected and the Council shall not entertain any request for relaxation in the cut-off date due to any reason, whatsoever.

An Expert Committee of the Council shall visit the proposed institution if the compliance of all the conditions are met before the cut off date. It shall be the responsibility of the Trust/Society to keep ready the documents and facilities prior to the Expert Committee's visit, as stated in Annexure III.

It is further stated that if the Trust/Society is not able to fulfill any of the requirements as mentioned above, it shall forfeit its claim for further consideration of the proposal. The Council shall not give any opportunity for re-consideration.

Kindly, note that this is only a Letter of Viability and is NOT a Letter of Approval.

ANNEXURE II

PROCEDURE FOR CREATION OF FIXED DEPOSIT IN THE JOINT NAMES.

The procedure prescribed by the Council for creating a FDR jointly in the name of the Trust/ Society and the respective Regional Officers is as follows :

1. The applicant Trust/ Society shall bring to the Regional Officer the application form from a Nationalized Bank duly signed along with the seal of the authorized signatory on behalf of the Trust/ Society.
2. The Regional officer shall affix his/her signature on the form and mark it with official seal.
3. The Trust/ Society shall create a single Cumulative joint Fixed deposit in the name of the Trust/ Society and Regional Officer. AICTE.(city) for a period of ten years in the Bank.
4. A declaration from the Bank Manager along with his/her name and seal on Form A(enclosed) shall be taken after the Fixed Deposit is created.
5. The original Fixed Deposit Receipt along with the Declaration in Form-A shall be submitted to the Regional Office before the cut-off date.
6. The Regional Officer shall retain the original Fixed Deposit Receipt and the duly signed Form A in safe custody and shall verify it periodically.

Note : The procedure mentioned above shall be strictly followed and if the original FDR is not deposited with the Regional Office before the cut-off date, the proposed Institution shall not be visited and no further consideration shall be given to the proposal.

Annexure III

- a. Approved master plan for the entire institutional complex with the details of the plinth area, for the facilities such as laboratories, class rooms, drawing halls, workshops, library, administrative block, hostels, etc., which are required for the programme.
- b. Proof of permanent built-up area as per norms alongwith layout plan and photographs of the premises where the Trust/Society proposes to start the Institute.





It has been decided that while AICTE will not insist on any nomination in the Governing Body of Private Unaided Institutions, the Affiliating University / State Government may impose minimum conditions of affiliation, such as, prescription of qualifications of Governing Body Members, in order to ensure academic excellence. It shall be desirable for the private unaided institutions to induct at least 50% of the members of the Governing Body drawn from renowned academia, academic administrators, Subject Experts and professionals from industry in order to seek their innovative ideas for continuous improvement in the delivery of teaching learning process, matching best practices elsewhere and achieve excellence.




However, should you have any documentary evidence to the contrary, you may appeal to the Council on or before June 15, 2004, with documentary proof, to enable this office to place your case before a duly constituted Appellate Committee. No appeal reaching the AICTE after June 15, 2004 will be considered.

DEFICIENCIES / SUGGESTED IMPROVEMENTS:

1. The Institution does not have the proper ambience for a educational institution
2. Proper Electrical Connection for power, such as an Electrical Sub-Station is not available.
3. Building Infrastructure and furnishing of room is only partly ready.
4. Classrooms are not equipped with fans
5. Drinking Water, Canteen, Common Room and other amenities for students are not available.
6. The internet connection, which is through a dial-up connection, is inadequate.
7. As the construction is not yet complete, the access to classrooms and library is risky.
